Page 1

This page shows the number of parcels sent per service, the basic price of the parcels, the surcharges and the sum of these amounts.



Services DPD

For each service, you will find the details

The split between VAT and non-VAT taxable amounts.



Quantity

The number of times a service was performed by DPD within one billing period.

Total Service Price

The total basic price per DPD service.

Total Service Additional

The total of all surcharges on parcels per DPD service.

Total Price

Total price per DPD service.

The total amount of the invoice split into:

- amount excluding VAT
- VAT
- amount including VAT

Terms of payment

The latest payment date for the invoice.
