Surcharges	Rates	Explanation
Energy surcharge	per month, variable	DPD calculates a variable energy surcharge on the parcel price for all services and products. This price is indexed, which means that we constantly adjust it according to the fluctuating energy prices. At dpd.nl/fuel you can find an up to date overview.
Digital invoice	per month, free	You will receive invoices in PDF format via e-mail. Your CSV file can be downloaded from our monitoring tool DPD Insights.
Tyre surcharge	per tyre € 3.35	Tyres to Finland, Norway, Sweden and Denmark that are not delivered in carton packaging, are provided by DPD with the correct packaging. A surcharge will apply for this.
Peak surcharge tyres	per tyre € 1.70	For shipping tyres a peak surcharge applies from 1 March to 31 May and from 24 September up to and including 24 December.
NSP (Non Standard Parcel)		<p>A parcel is considered a Non Standard Parcel if it meets one of the underneath criteria.</p> <ul style="list-style-type: none"> A parcel has a length or is measured diagonally longer than 130 cm; The parcel is heavier than 20 kilograms; The parcel has an unstable, irregular shape (sphere, cylinder, roll); The parcel is not, or is not properly packaged, according to the packaging guidelines (see dpd.com/nl/en/support/packing/); A parcel that, for whatever reason, requires additional manual handling or sortation. <p>If a parcel is larger than 175 cm, heavier than 31.5 kg or has a dimension over 300 cm, only the surcharge for excess on dimensions and weight will be applied.</p> <p>DPD has different NSP categories. Classification per category depends on the number of NSP parcels up to the total number of parcels.</p> <p>The rate applies to all NSP parcels that you send with DPD.</p>

Excess dimensions and weight for a 'normal parcel' (NP parcel)	per parcel € 46.50	<p>DPD applies maximum dimensions and weights to parcels. A surcharge will apply when the dimensions of 'normal parcels' are exceeded.</p> <p>The surcharge applies to a parcel when it exceeds the following measures or weights:</p> <ul style="list-style-type: none"> A parcel has a length or is measured diagonally longer than 175 cm; The parcel is heavier than 31.5 kilograms; The parcel has a dimension over 300 cm (for tyre parcels the limit is 290 cm). <p>When this surcharge applies, the NSP surcharge will not apply.</p>
Excess dimensions and weight for a 'small parcel' (KP parcel)	per parcel € 7.50	<p>DPD applies maximum dimensions and weights to parcels. A surcharge will apply when the dimensions of 'small parcels' are exceeded.</p> <p>The surcharge applies to a parcel when it exceeds the following measures or weights:</p> <ul style="list-style-type: none"> A parcel has a length or is measured diagonally longer than 50 cm; The parcel is heavier than 3 kilograms; The parcel has a dimension over 111 cm.
Age check	per parcel € 1.84	Surcharge for checking if the consignee is 18 years or older. Mandatory for the delivery of alcohol and tobacco in the Netherlands.
Interventions that cannot be performed using software	per request € 2.79	A surcharge applies for modifications that cannot be performed using standard DPD software and which therefore require manual processing by a DPD staff member.
>12-month Proof of Delivery	per proof of delivery € 2.79	A Proof Of Delivery (POD) can be requested from Customer Service for up to 12 months. That term starts on the day that the parcel was, or should have been, delivered. A surcharge applies to requests for a POD submitted after 12 months. No PODs will be issued after 24 months.
Labels without DPD software	per parcel € 1.12	DPD enables all its customers to use DPD software or an approved label they have designed themselves. If neither of these options are used, a surcharge will apply.

Inability to complete collection requests	per parcel € 2.85	If DPD cannot complete a Collection request for reasons beyond the control of DPD, a surcharge will apply.
Return non-deliverable or rejected parcels	DPD Business rate + € 2.85	Parcels which could not be delivered, were rejected by the receiver or did not get collected during the storage time at the parcelshop (7 days) or locker (5 days), will be returned to the sender. Parcels that were rejected by the receiver will be returned immediately. For returning these parcels, a surcharge will apply.
Relabelling	Per parcel € 0.71	In order to (re)apply a parcel label by DPD we might apply a surcharge.
Toll	1.3% per parcel, The Netherlands 4.6% per parcel, to Belgium 2.7% per parcel, through Belgium 5.2% per parcel, to Germany 3.75% per parcel, through Germany	DPD will have 3 toll surcharges: The Netherlands, Belgium (through and to), and Germany (through and to). The percentages will be charged per parcel and will be visible as a total charge on the invoice. Please find below an overview of the countries charged with toll.

Excess dimensions or weight	per parcel € 22.75	DPD applies the surcharge if the maximum weight of 31,5 kg and 70 kg per shipment is exceeded. For parcels with a length >1.50 m the surcharge applies. If a parcel or a shipment is oversize and overweight, the surcharge will be applied only once.
Remote area	per parcel € 22.75	A surcharge applies for remote areas. See www.dpd.com/nl/en/rates-dpd/ for the zip code overview Remote Area.
Return	per parcel € 22.75	A surcharge applies for the return of an undeliverable parcel.
Administrative fee	per parcel € 22.75	A surcharge applies in case of invoicing of additional costs (duties and taxes for instance).
