## What makes us special?

## DPD parcel – standards:

- **Maximum permitted weight:** 31.5 kg in domestic and international traffic.
- **Maximum permitted length:** 175 cm in international traffic and in domestic traffic.
- **The sum of the circumference and the longest side** is 300 cm: circumference = 2 x (height + width) + length of the longest side
- If the sender submits a parcel that, according to the volumetric calculation, is heavier than the actual weight in kg and this parcel is to be delivered within Slovenia or abroad, such parcel will be charged according to the weight, which is higher according to the calculation. Volumetric weight is calculated according to the formula: height\*width\*length in cm / 5000.
- **For delivery of parcels to the Pickup location:** maximum weight 20 kg, maximum length ≤ 100 cm, maximum circumference ≤ 250 cm.
