1. Promoter

2. Competition name & brief

“Gnome On The Go” featuring Delvan the DPD gnome. During November 2025, DPD will place 6 000 red DPD gnomes into random parcels delivered nationwide. Finding a gnome does not guarantee a prize; it allows you to enter as set out below.

3. Who may enter

- Open to legal residents of South Africa, 18 years or older.
- Employees, directors, agents and contractors of the Promoter, and their immediate families/households, are not eligible.
- If you are under 18, you may only enter with the consent and supervision of a legal guardian (who must accept the prize on your behalf).

4. Competition period

The competition runs from 00:01 SAST on 3 November 2025 to 23:59 SAST on 21 November 2025 (“Competition Period”). Entries outside this period are not valid.

5. How to enter & Qualify

If you find Delvan in your parcel during the Competition Period:

2. Post a photo of Delvan having festive fun in your home;

6. Prizes
